Introduction

The Healthy Bees Plan 2030 was published in November 2020 alongside a review of the original Healthy Bees Plan, which had been in place from 2009 to 2019.

This Implementation Plan develops the four outcomes set out in the Healthy Bees Plan 2030 into manageable actions. Bee Health stakeholders will work together over the next ten years on these actions and any others identified, to improve the health of honey bees across England and Wales. As with the new Healthy Bees Plan, this implementation plan has been developed together with bee health stakeholders and actions have been identified that can be taken, not just by government, but individually or jointly by stakeholders and the wider beekeeping community.

The four broad outcomes in the Healthy Bees Plan 2030 that we will work towards are:

- 1. Effective biosecurity and good standards of husbandry, to minimise pest and disease risks and so improve the sustainability of honey bee populations;
- 2. Enhanced skills and production capability/capacity of beekeepers and bee farmers;
- 3. Sound science and evidence underpinning the actions taken to support bee health; and
- 4. Increased opportunities for knowledge exchange

Some of the actions set out in the following pages were identified from the review of the first Healthy Bees Plan, while others emerged from subsequent Bee Health Advisory Forum discussions. Actions have been assigned owners and a timescale for delivery. The new plan runs for 10 years but the implementation plan will be refreshed approximately every 3 years, allowing a light-touch review of:

- (i) actions completed to date;
- (ii) actions ongoing;
- (iii) whether any new actions need to be added.

Work is ongoing with stakeholders to identify suitable measures of success so that progress can be monitored for each of the actions set out in the Implementation Plan.

Many partners in the Healthy Bees Plan 2030 commission or contribute to research and will continue to do so individually and with others. The plan does not, however, envisage a shared funding resource, rather a sharing of ideas and priorities to provide a complementary programme of research.
